#### Introduction

Beginning July 1, 2021, existing certified staff (i.e. principals, assistant principals, teachers, instructional support) and certain classified staff (i.e. OT, PT, Nurses, Behavior Support, and Youth Development Coordinators) will complete a minimum of 6 hours of training as outlined in the School Mental Health Policy. Newly hired certified staff and certain classified staff will complete this course bundle within the first 6 months of employment through the New Hire Packet provided by ACS Human Resources. The initial training requirement may be waived for a new employee who completed such training at another district within the previous twelve months.

Instructional support personnel is defined as follows.

The complete Every Student Succeeds Act of 2015 Definition of Specialized Instructional Support Personnel: Title VIII, SEC. 8002 includes the following: The term 'specialized instructional support personnel' means— i) school counselors, school social workers, & school psychologists; & ii) other qualified professional personnel, such as school nurses, speech language pathologists, & school librarians, involved in providing assessment, diagnosis, counseling, educational, therapeutic, & other necessary services (including related services as that term is defined in section 602 of the Individuals with Disabilities Education Act (20 U.S.C. 1401) as part of a comprehensive program to meet student needs.

In subsequent years, existing certified employees and certain classified staff will complete two hours of subsequent training as outlined below. The training in subsequent years will be aligned with the requirements of SB 199 which requires school districts to provide 2 hours of training on child sexual abuse and child sex trafficking in even numbered years.

Professional development for Student Services personnel (i.e. school counselors, school social workers, and school psychologists) will be differentiated to meet their professional needs. These sessions will feature district staff and community subject matter experts. The agenda for sessions will focus on the role of Student Services personnel, linking

students and families to internal and external resources, district procedures and protocols, and intervention strategies for students.

The ACS Central Support Services Office will work with school administrators to outline a plan to allow certified staff to receive CEU credit for completing the course bundle outlined below.
