

MINUTES
ASHE COUNTY BOARD OF EDUCATION
February 3, 2015

The February meeting was held at Ashe County High School as re-scheduled due to inclement weather. All members were present; however, C.B. Jones was late due to his work schedule. Chairman King called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

The agenda for the meeting was approved by general consensus.

Superintendent Holden thanked Edwina Parsons and Sherrie Harless, cafeteria managers, and their staff for preparing the refreshments for the reception.

Superintendent Holden recognized the following individual school *Teacher Assistant of the Year* nominees and presented each with a certificate acknowledging their achievement: Dwayne Farmer, Ashe High; Judy Stallings, Blue Ridge; Pam Potter, Mountain View; and Sherry Shepherd, Westwood. Pam Potter was then recognized as the *2014/15 Ashe County Teacher Assistant of the Year*.

Board Member Polly Jones recognized the following individual school *Teacher of the Year* nominees and presented each with a certificate acknowledging their achievement: Keana Triplett, Ashe High; Gordon Prince, Ashe Middle; Summer Severt, Blue Ridge; Frances Eller (absent), Mountain View; and Kristina Norris, Westwood. Keana Triplett was then recognized as the *2014/15 Ashe County Teacher of the Year*.

Board Member Terry Williams recognized participants in the Governor's Teacher Network—Courtney Eller, Rachel Nave-Lewis and Sonya Vannoy.

Board Member Dr. Lee Beckworth recognized Ashe High teachers Josh Beckworth, Christy Rivers and Keana Triplett as recipients of the *2014 National Board for Professional Teaching Standards (NBPTS)* certification and presented each with a certificate acknowledging their achievement.
